1) Core Group meeting

The Action' Core Group (CG) met in the morning of the 4th October 2022. The topics for discussion were Housekeeping of the hybrid-held Workshop, State of the art report, Heatmap collision survey and Next year's events.

a. Housekeeping of the hybrid-held Workshop

The following decisions were made:

- The Workshop is run over Zoom. However, the Miro app (Chalmers provides the licence) is used throughout the meeting, participants check Zoom chat for the link to access it.
- Comments following presentations should be initiated by raising (and the lowering) a hand in Zoom. Participants will then be asked to speak. The organisers do their best to keep the order of questions.
- Same goes for the in-person crowd.
- Keep questions and comments short and concise. Feel free to elaborate on the Miro app.
- Some WG's have discussion planed after SG presentations, some in bulk at the end.

b. State of the art report

After reviewing the draft STAR reports, we found the following:

- The paper length allowed is 2-4 pages (before 2-3)
- Keep the figures in the papers only if they are really important, and if you have the copyright.
 Don't have copy-paste of pictures from other papers, even if they are yours please modify them at least slightly.
- Remove keywords from individual papers.
- Topics should be on tall(er) timber building issues and not one-family housing.
- Delivery dates:

 - o Revised abstracts circulated within the Action members: 26, 10, 2022
 - o Final STAR: 01. 12. 2022

c. Heatmap collision survey.


d. Next year's events.
